<p><b>How will your child access remote learning?</b>          In the event of a whole-class isolation, we ask that children access teaching through the use of Microsoft Teams and SeeSaw. These applications can be accessed using a smartphone, tablet or laptop. We can support you with accessing these platforms if necessary.</p>	<p><b>What teaching will be accessible to my child?</b>          Each day, there will be an overview of our phonics, writing and maths learning, a live reading of a class novel and follow-up learning activities posted on SeeSaw, which meet the individual needs of the children.</p>	<p><b>What do I need to do to support my child?</b>          Each day please ensure that your child attends morning registration on Microsoft Teams. Then work with your child to complete the daily activities on SeeSaw. Also, encourage your child to access the suggested websites to further develop learning and skills.</p>
<p style="text-align: center;"><b>CHILDREN</b></p> <p><b>I promise to:</b></p> <ul style="list-style-type: none"> <li>• Follow our school values of Responsibility, Respectful, Determination and Resilience at all times.</li> <li>• Try my best to complete all daily learning tasks.</li> <li>• Complete the work my teacher sets through SeeSaw by <b>1:30pm</b> each day.</li> <li>• Use the rest of my time to listen to uploaded stories, and access suggested websites from my teacher.</li> <li>• Wear appropriate clothing when I am using Microsoft Teams with my class for morning registration</li> <li>• Focus and not get distracted with the things happening at home</li> <li>• Mute my audio when the teacher is talking</li> <li>• Listen to my teachers during registration and listen to the grown-ups at home who are helping me with my learning activities.</li> </ul>	<p style="text-align: center;"><b>TEACHERS</b></p> <p><b>I promise to:</b></p> <ul style="list-style-type: none"> <li>• Meet with my class each morning to take the register and have a 'check in'</li> <li>• Provide maths and English and other subject specific activities on SeeSaw which you can complete after the uploaded lesson each day</li> <li>• Check work, provide feedback using the SeeSaw app, and amend planning for the following day.</li> <li>• Give you feedback on your activities that you post on SeeSaw.</li> <li>• Upload a daily recorded story session on seesaw.</li> <li>• Show you fun websites where you can enhance and develop your skills.</li> <li>• Follow the staff Code of Conduct and acceptable use of ICT Policy as usual.</li> </ul>	<p style="text-align: center;"><b>PARENTS/CARERS</b></p> <ul style="list-style-type: none"> <li>• We ask that parents and carers support the delivery of remote learning by discussing this agreement with children.</li> <li>• Parents and Carers to be close by whilst child is on daily morning registration teams meeting. The time for daily registration will be the same time as current class bubble start times.</li> <li>• Parents/Carers must inform school if a pupil is unable to attend remote registration/learning by emailing <a href="mailto:GH-Enquires@ipmat.co.uk">GH-Enquires@ipmat.co.uk</a></li> <li>• Pupils not present without an explanation will receive a phone call from the school office or Learning Mentor in line with usual attendance procedures</li> <li>• Send all completed activities and evidence of any other home learning to SeeSaw by 1.30pm each day.</li> </ul> <p style="text-align: center;"><b>Keeping Safe Online</b></p> <p style="text-align: center;">The school has a "Remote Learning and Safeguarding" document, which sets out how we will ensure all children and staff keep safe online.
